#### Approval of minutes from the 12/06/22 meeting (Bartol)

**APPROVED** with one change: Priti Prabhu's name was omitted.

#### Treasurer's Report (Weber)

The M&T account currently totals \$37,000 (up from \$23,508 while the Vanguard account as at \$156,000 (up one thousand), all totaling \$198,800 (up from \$179,000).

The club has 105 active members (same as last month), and 31 inactive (up from 30).

Projected annual net income (less costs of collections): \$94,000 per year.

## Membership gains and losses (Prabu)

Court usage over the last month has been almost 30% (same as last month), but this includes clinic booking times. Note: we continue to have problems with members not showing up for reserved sessions.

Added 3 new members have joined this month. Talking with 1 more to come in this month.

Website is still well out of date.
